To consider and pass the following resolution:  <b>THAT</b> the extension of validity period of resolutions in respect of the proposed issue of not more than 20,000,000 A shares of the Company with a nominal value of RMB1.00 each (the "Proposed Issue of A Shares") and related matters (the resolution was approved as a resolution by Shareholders, the holders of domestic shares of the Company (the "Domestic Shareholders") and the holders of H shares of the Company (the "H Shares") at the special general meeting, the class meeting for Domestic Shareholders and the class meeting for holders of H Shares of the Company held on 1 November, 2017, respectively) be and are hereby approved, including the extension of validity period of the authorization to the board of directors of the Company to deal with matters relating to the Proposed Issue of A Shares. IF YOU WISH TO ABSTAIN FROM VOTING ON ANY RESOLUTION, TICK IN THE BOX MARKED “ABSTAIN”, AND YOUR VOTES WILL BE COUNTED FOR THE PURPOSE OF CALCULATING THE RESULT OF THAT RESOLUTION.** Failure to tick the box will entitle your proxy to cast your vote at his discretion. Your proxy will also be entitled to vote at his discretion on any resolutions properly put to the Class Meetings other than those referred to in the Class Meeting Notices.

This form of proxy must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, either under its seal or under the hand of an officer, attorney or other person authorized to sign the same. If this form of proxy is signed by an attorney of the appointer, the power of attorney authorizing that attorney to sign, or other document of authorization must be notarially certified.
6. Any Shareholder entitled to attend and vote at the Class Meetings of the Company is entitled to appoint another person as his/her proxy to attend and vote instead of him/her. A proxy needs not be a Shareholder of the Company. A Shareholder who is the holder of two or more Shares may appoint more than one proxy to represent him/her and vote on his/her behalf at the Class Meetings.
7. This form of proxy and the power of attorney or other authority (if any) under which it is signed, or a notarially certified copy of such power of attorney, must be delivered to the Company’s H Shares registrar at Tricor Tengis Limited at 22nd Floor, Hopewell Centre, 183 Queen’s Road East, Wanchai, Hong Kong not less than 24 hours before the time appointed for holding the Class Meetings or adjourned meeting.
8. In the case of joint registered holders of any Share, any one of such persons may vote at the Class Meetings, either personally or by proxy, in respect of such Shares as if he was solely entitled thereto; but if more than one of such joint holders be present at the Class Meetings, the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holder(s), and for this purpose seniority shall be determined by the order in which the names stand in the register of holders in respect of the joint holding.
9. Completion and return of the form of proxy will not preclude you from attending and voting at the Class Meetings if you wish to do so. A proxy attending the Class Meetings must present a proof of identity.
